For the genuine grievances, redressal has taken and the suggestions are also collected every now and then.

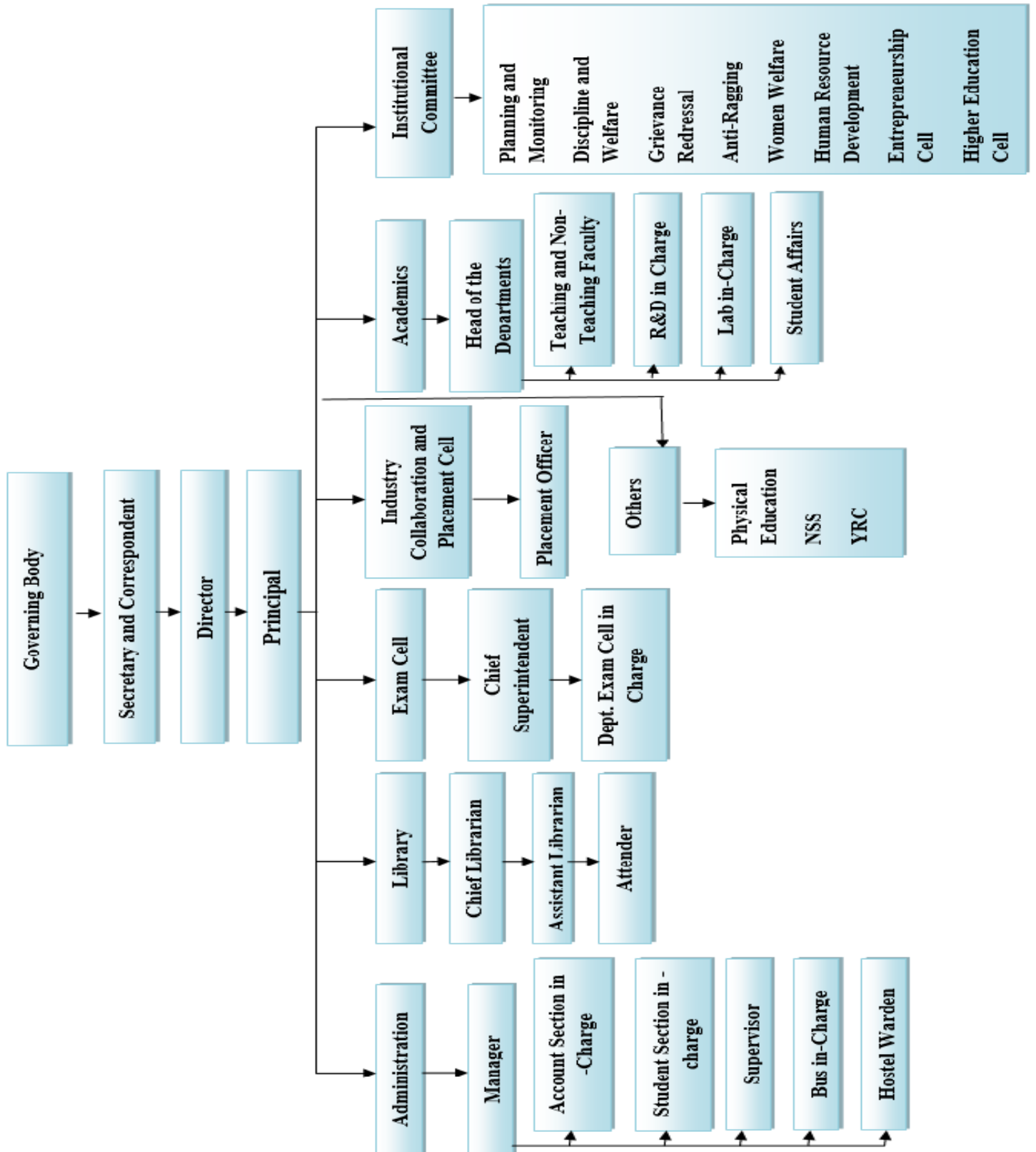
Grievances are probably related to teaching of the faculty or the behavior of the students or other infra-structure facilities.

11. Organization chart

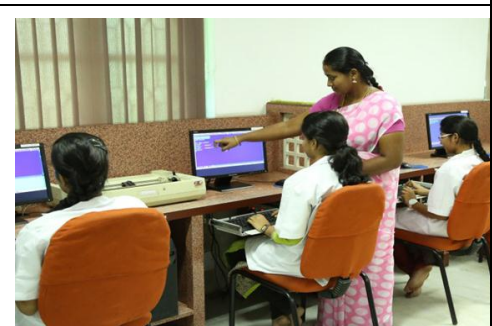

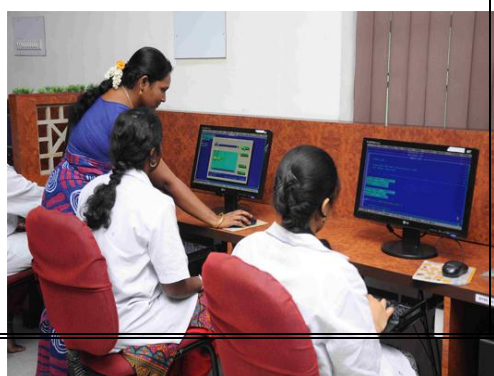
